

December Council Meeting

DEVOTIONS: Jenny Luffy

ACCEPT AGENDA: Made clear that there would be discussion of a part-time vs. shared pastor as part of the meeting. Agenda approved.

COMMUNICATIONS: N/A

OFFICER REPORTS:

- 1. Interim Pastor report accepted as presented. Pastor Paul stated that he had visited both Charlotte Hein and Carole Bridges in December and that the confirmation class was going well.
 - 2. November Council Meeting minutes accepted as presented.
- 3. Treasurer's Report accepted as presented. Barb Tychinski was present to answer any questions. She plans to start investing more as we are currently holding too much money in the checking account.

COMMITTEE REPORTS:

- A. CHRISTIAN EDUCATION—there will be no Sunday Club on December 24th or December 31st
 - B. COMMUNITY FELLOWSHIP—
- 1. Light Up Night was a huge success with more than 250 in attendance. Huge thanks to West Point Fire Department (Miles and Donna Webb) and our sub-committee for another great year. The hope is to keep growing and look forward to Light Up Night 2024.
- 2. Next event is the Chili Cook Off on Saturday, January 6th.
- C. YOUTH—went to see the movie "Wonka" on Saturday, December 16th at AMC Theaters
 - D. PROPERTY—
- 1. Jason Blotzer mowed the grass for the Light Up night event for \$150.
- 2. Building updates—Final bathroom upgrades were ordered and need installed. Baby changing tables have been installed.

New bathroom partitions were ordered. Awaiting paper quote for hard wiring the doorbells; verbal quote was \$250 each. New desk (gifted) for Office Coordinator was ordered with hopes of it being installed the first week of January. New boiler has been installed along with four (4) new thermostats to replace old ones. Sanctuary split heaters temp was dropped to 70 degrees as recommended by Tim Donahue to match boiler temp.

3. Handicap parking—Jenny brought up that she saw members driving around the parking lot last Sunday looking for a closer place to park and suggested that we add three additional handicap spaces with the painting to be done in the spring.

NEW BUSINESS:

- A. Proposed 2024 Budget—presented by J. Gesalman, Financial Secretary. Said between now and the congregational annual meeting it may need tweaked if additional pledges come in, etc.
 - B. Accept 3% of the Teeter estate (\$12,000) as offered.
- C. Accept 10% from other estate with a Property offer complication. Kathy presented the plot plan for the offered property and noted that the property is wooded and steep with the Mt. Pleasant Road the only access. There are no mineral rights associated with the property. Second motion needed to accept the 10% from the estate as offered. Jack to inform the estate attorney of the council's decisions.
- D. Designate committee or Person to head the Capital Fund Drive for Boiler. Finance Committee will assist behind the scenes. Denny offered to head the fund drive. Jack given permission to make the thermometer and put designated envelopes in the pews. The first payment towards the \$30,000 loan has already been made per Barb. Both the council and the congregation approved a payment of \$6,000 per year. Denny also offered to call some people to serve on a committee regarding future initiatives to bring to the Finance Committee. Amy suggested that two of the items might be blinds and lights in the social room.
- E. Council positions for 2024—seven (7) positions will need filled. Denny, Bonnie, Jessica, Joy, Dee and Andrew are eligible to run again and have indicated that they will. Greg has reached the end of his second term and cannot run. Denny has indicated that he is interested in a two-year term. Elections to be held at the annual congregational meeting in January.
- F. Newsletter mailing results—A question was included in the newsletter asking how the household would like to receive future

newsletters. Out of 224 newsletters mailed, twenty-one (21) responses were received back with the following results...one (1) wanted to read online, eleven (11) wanted to have their newsletter mailed and nine (9) wanted to pick up at the church. For those that did not respond, the newsletter can be picked up at the church or viewed online. Those making the formal request to pick up at the church will have theirs labeled. Based on the results the church's bulk mailing permit will probably not be renewed. Jenny suggested that an email be sent through Power Church asking the same question and Pastor Paul suggested that slips be available in the weekly bulletin that can be put in the collection plate as a response also.

- G. Jack Gesalman is resigning as Financial Secretary and will accept a nomination as Assistant Treasurer in January. No action taken at this time.
- H. Quote for new yard maintenance for 2024—Due to the tractor's unreliability the council has decided to hire Jason Blotzer, who has his own equipment, to cut the grass (\$150) and do the edging when needed (\$50). Thanks to Alex Ryan for maintaining the grounds last summer.
- I. Part-time vs. Shared Pastor—Two cottage meetings were held and council discussed whether or not more information was needed from the congregation in order to make a decision on part-time vs. sharing a pastor. Polling at the cottage meetings indicated that more wanted to share a pastor. Some council members felt that sharing could increase the number of youth involved in church activities and that the church would have more potential for growth. Bonnie cautioned that when considering a pastor from another church to see if that other church was handicap accessible, not just for her, but for other Good Shepherd members as well. A "show of hands" vote was then taken.
- J. Snow removal—Tobin has the snow removal contract and Bonnie asked that when they plow on Sundays could the Fairfield parking area be plowed also so that she would not have to go down the ramp to enter the church? The door should also be unlocked. Tobin to be notified.

D. Property

- 1. Men's restroom stall was replaced; at the door was improperly installed and had to be reordered. - E. Vote on Flooring Replacement—several council members were surprised to see the motion on the agenda of the Annual Congregational Meeting for additional replacement flooring. The following issues were discussed: Although items can be placed on the annual meeting agenda without being advertised, council as a whole and the interim pastor should have been made aware of the flooring motion prior to the meeting. Council members' questions should have been raised at the time of the annual meeting and the motion was not made as a result of an executive board meeting. Brian made the suggestion that in the future the Annual Congregational Meeting agenda be approved in advance by council, possibly at the December meeting,
- F. Linda explained that she has a background in purchasing and would be willing to help with the negotiation of purchases for the church.

First Communion Classes Begin Sunday, February 11

As children grow in their faith and understanding, they enter into new phases of their relationship with God. One important milestone in this growth is First Communion. Children who are in second grade or seven years old are of the age when they can more fully comprehend the meaning of Holy Communion. Children of this age are invited to attend First Communion classes in February. Over the course of three Sunday morning classes, they will learn about Jesus' love and concern for all people, the Last Supper, and what the presence of Jesus Christ in the bread and wine of communion means. The three classes will be held on **Sunday** mornings at 9:30 am, on February 11, 18, and 25. The participants will receive First Communion on Sunday, March 3, at the 10:30 am Worship Service. Students are expected to attend all three classes. The class will be taught by Pastor Ed. Please speak to Pastor Ed to register your child for the class, or if you have any questions about the class.



Ash Wednesday Service – Feb 14 – 7:00 pm

Each year, Ash Wednesday begins the season of Lent. On Ash Wednesday, we begin our forty-day journey toward Easter with a day of prayer and repentance. Marking our foreheads with ashes, we acknowledge that we die and return to the earth. At the same time, the ashes trace the life-giving cross of Jesus Christ indelibly marked on our foreheads at baptism. It is a time of reflection and renewal, as we recommit ourselves to living our lives as believers and followers of Jesus.

The service consists of both the receiving of ashes, as a sign of repentance, and holy communion, as a sign of Jesus coming again into our lives.



Mid-Week Wednesday Lenten Services – Soup & Sandwich Supper – 6:00 pm / Service – 7:00 pm

During the season of Lent, the congregation hosts a series of Soup and Sandwich Meals and Lenten Services each Wednesday after Ash Wednesday. The simple supper begins at **6:00 pm**. Soup is provided; please bring your own sandwich. The theme of this year's Lenten services at **7:00 pm** is "Rocks and Stones." At each of the five services, both the Psalm and the Gospel reading make reference to stones or rocks. Hand-size stones will be provided at the services for each worshipper to use, as a physical reminder of the biblical passages. The dates and themes of each service are below.

Feb 21 - Judgement - Mt 18: 6-9 ("those who lead others into sin should be thrown into sea with a stone tied around their necks")

Feb 28 - Foundation - Mt 7: 24-27 ("a wise person builds a house on solid rock")

Mar 6 - Destruction - Luke 21: 1-6 ("the stones of the Temple will be torn down")

Mar 13 - Rejection - John 10: 22-39 ("once again the people picked up stones in order to kill Jesus")

Mar 20 - Compassion - John 8: 1-11 (woman caught in adultery - "If any of you have never sinned, then go ahead and throw the first stone at her")




